



## Election Results for Board of Managers 2022

The Association's Annual Meeting of Unit Owners was held at the Clubhouse on June 14, 2022. With 438 Unit Owners voting, we exceeded the quorum requirement of 285 units. There were candidates in Ward 1 and Ward 5; there were no candidates in Wards 2, 3, and 4.

Ward 1 - Bill Reck, 76 votes (uncontested)

Ward 5 - Debra Behrendt, 68 votes; Dwight Schofield, 47 votes

The winner in Ward 1 is Bill Reck. The winner in Ward 5 is Debra Behrendt. Bill Reck is new to the Board and Deb Behrendt is returning for a second term. Both were seated at the Annual Meeting. Congratulations, Bill and Deb!

**The new board consists of the following members:** Bob Horton and Bill Reck; Ward 1; Bryan Fay, Ward 2; Katie Hebson, Ward 3; Jeff Forrler, Ward 4; and Debra Behrendt and Yvonne Homeyer, Ward 5. There are three vacancies. See article below on how to apply for an appointment to a vacant seat.

#### PRESIDENT'S CHAT

#### **Election for Board of Managers**

The results of the election for the Board of Managers are on page one. Please welcome new Board member Bill Reck in Ward 1 and returning Board member Debra Behrendt in Ward 5. Both were seated at the Annual Meeting.

#### **New Officers**

The Association has three officers and their terms are for one year: President, Secretary, and Treasurer. Officers are chosen by the Board. By the time you get this newsletter, the new Board will have chosen the officers for the coming year. We will send a Constant Contact email as soon as we know who the new officers will be. Many thanks to Bryan Fay for his service as Secretary and Katie Hebson for her service as Treasurer this past year.

#### Changes on the Board

I would like to thank outgoing Board members George Stenseth, Bob Behymer, and Mike Slaughter for their service on the Board. Their terms ended at the Annual Meeting on June 14. Being a Board member requires a large commitment of time and energy that goes beyond attending the monthly Board meetings. On behalf of all the Unit Owners, thank you for your dedication to Brentwood Forest. Without you, the Association could not function.

#### **Extension of Current Contracts**

A big shout-out to our General Manager, Kent Allen, for getting three of our largest contractors to agree to a one-year extension of their contracts without any price increase. Contracts with Greenwood Group (landscaping, irrigation, and snow removal), Herbster Hellweg (painting), and DNI (bookkeeping) were all due to expire in the next few months. Kent negotiated with each of these three vendors and they all agreed to extend their contracts for twelve months beyond the expiration date without any increase. This is a

huge benefit, especially in a period of high inflation. The extensions were approved by the Board at the May 31 board meeting.

#### **New Financial Advisor**

Please welcome Tedd Schlereth to the Brentwood Forest team of professional advisors. At the May 31 board meeting, the Board approved switching our long-term reserve account to Tedd Schlereth, an experienced financial advisor with Ameriprise. This decision followed a months-long search spearheaded by our Treasurer, Katie Hebson. The new board will be meeting with Tedd in the near future to discuss investment strategies for our long-term reserves.

#### **Arborist**

The Board approved a contract with an affiliate of Davey Tree Service to perform an evaluation of the trees on our property. This survey should get underway sometime in July. The information generated by this evaluation will guide us in decisions about tree maintenance and removal. Board member Jeff Forrler was the driving force behind the idea of hiring an arborist.

#### Courtesy and Respect

Please remember to treat our employees and on-site contractors with courtesy and respect. If you have an issue that needs to be addressed and our administrative staff cannot solve it, contact our General Manager, Kent Allen. Kent is in charge of all Brentwood Forest employees and all outside contractors. Also, please let our employees know how much you appreciate them. Stacey and Mary Beth are our administrative assistants and Vince, Don, and Patrick are our maintenance crew. The next time you see them, please say "thank you" for everything they do for us, every day.

#### **Pools**

Pool season is in full swing and Melanie is, as always, doing a great job managing both pools and making sure that they are spotlessly clean and ready for us to enjoy. We are lucky that Unique Pools, our pool management company, has been able to provide *full lifeguard coverage* for both of our pools. So far we have not had to curtail hours due to lack of a lifeguard, an issue that other pools around our area have had to deal with. Great job, Melanie and Doug!

#### **Insurance Policies**

Our Master Policy, Earthquake Insurance, and other insurance policies all come due on September 15 which means that the Board needs to make all insurance decisions by the August board meeting. Summer is always a hectic time as we await news of premium increases from existing carriers, and our brokers review all our options. Insurance premiums are a large part of our budget and have a big influence on our condo fees.

#### **Budget for 2023**

The budget process will get underway in early August. This year, we have the advantage of knowing in advance what our costs will be for landscaping, irrigation, painting, and bookkeeping because we don't have to go through the RFP and bidding process (due to the one-year extension with three contractors see above.) Snow removal cost is based on weather and that is a guessing game; we have learned that budgeting high is safer than budgeting low. We will know our insurance premiums by August. All of those expenses are major components of our budget. If you want to participate on the Budget Committee, let Kent Allen know.

It has been an honor to serve as your President this past year. I look forward to another year on the Board and serving Brentwood Forest in whatever way I can.

I would like to update everyone on our progress with trash bags and trash containers. We have seen an improvement with trash bags being placed out for trash pick-up. There are still some residents that are not observing the trash bag rules. Please use a hard-sided trash container to dispose of trash bags. The trash service will not pick up loose trash bags. If BFCA staff has to pick up loose trash bags and dispose of them in our dumpster, it is an added expense to every unit owner in Brentwood Forest for trash removal.

#### Trash container storage has made progress but still needs improvement.

Trash containers along with recycling containers can only be stored on the sides and back of buildings. No front deck or front of the building storage is acceptable. Trash bags may be placed in the trash container no sooner than dusk on the night prior to trash pick-up day.


A reminder that recycling is on Mondays only. We are seeing more recycling being put out on Thursdays which the trash service will not pick up. Again, this is an added expense to every unit owner in Brentwood Forest, and the items are not being recycled. Our office has large 65-gallon recycling containers available if you should need one.

Large items will not be collected by our trash service. This would be items such as (but not limited to) furniture, sinks, toilets, appliances, lawn furniture, carpet...etc. This could be a very long list. The trash service will only dispose of trash bags in hard-sided containers, no bags on the ground or recycling. That is their only responsibility. BFCA staff will not dispose of these items. These items will be left out until we can find the owner of the items. If you have items such as this, you can call either the City of Brentwood for special pick-up or an independent service of your choice. #### **Manchester Road Closure**

As you are most likely aware by now, Manchester Road is completely closed just west of the intersection with Hanley Road. This will remain closed through August. The detour around the closure is north on both Brentwood Blvd. and Hanley Road to access Eager Road going east and west. As expected, this has created a lot more traffic on Brentwood Blvd, that Brentwood Forest residents have assuredly encountered. Your continued patience is appreciated, and please remember to go slowly and come to complete stops at all stop signs. With the increased traffic around Brentwood Forest, the Brentwood Police Department has been running additional "traffic details" to catch speeders who are trying to unsafely avoid the traffic. What they have found is that most of these infractions are being committed by our own residents.

With the Manchester Road closure, the City of Brentwood also reminds residents to please support businesses along Manchester Road that are still open during this time. As we all know, it has been a tough last few years for these businesses already, and now with the decreased visibility of their businesses along the closed route, they could use our support more than ever.

#### **Eco-Friendly Bird Scooters**

This summer, the City of Brentwood and Bird are teaming up to bring shared e-scooters to Brentwood. The eco-friendly transportation can be activated through Bird's free mobile phone application and used to replace gas-powered car trips when going to the store, meeting up with friends, exploring the community, and taking many other daily trips.

100 Bird scooters will be distributed in Brentwood and three other partnering communities — Clayton, Maplewood, and Richmond Heights.

# Sprucing Up for Summer

Now that the weather has turned hot and dry, the irrigation systems have been turned on and are operating on the property. As with anything mechanical, repairs are necessary to keep the systems running properly. If you see any leaks or specific problems in your neighborhood, please report them to the office so that we can address them as quickly as possible. Your cooperation is greatly appreciated. We have begun the pruning process and will be moving through the property during the next month. Please note that some shrubs will not be pruned at this time due to the fact that they flower during the summer months. These include rose of Sharon, crape myrtle, and shrub roses. Summer flowering shrubs are pruned during the winter months when the plants are dormant. If you have a shrub that you would NOT want to be pruned, please put a yellow tag on the shrub to identify your request. Yellow tags can be obtained in the office.
